**POLL RESULTS OF
THE EXTRAORDINARY GENERAL MEETING
HELD ON 7 JULY 2016**

The Board is pleased to announce that the resolution proposed at the EGM held on 7 July 2016 was duly passed by the Shareholders by way of poll.

Reference is made to the circular (the “**Circular**”) and the notice of the EGM dated 21 June 2016 of Central Wealth Financial Group Limited (the “**Company**”). Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as defined in the Circular.

The Board is pleased to announce that the resolution proposed at the EGM held on 7 July 2016 was duly passed by the Shareholders by way of poll. The Company’s share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed the scrutineer for the purpose of vote-taking at the EGM. Details of the poll results of the resolution proposed at the EGM were as follows:

As at the date of the EGM, the total number of issued Shares in the Company was 5,777,587,998. As at the date of the EGM, Skyway Group holds 120,576,000 Shares and is required to abstain from voting at the EGM due to its interests in the Disposal and has been so abstained. The total number of Shares entitling Shareholders to vote for or against the resolution proposed at the EGM was 5,657,011,998. There was no Shareholder who was entitled to attend the EGM but was only entitled to vote against the resolution at the EGM.
