**POLL RESULTS OF THE ANNUAL GENERAL MEETING

At the annual general meeting of Future World Financial Holdings Limited (the “**Company**”) held on 31 May 2017 (the “**AGM**”), all votes on all the proposed resolutions as set out in the notice of AGM dated 27 April 2017 were taken by poll.

As at the date of the AGM, the issued ordinary shares of the Company were 6,485,187,998 shares, being the total number of shares entitling the holders to attend and vote for or against all resolutions. There were no restrictions on any shareholders casting votes on any of the proposed resolutions at the AGM.

All the resolutions, which were voted on by poll, were approved by shareholders of the Company. The vote-taking at the AGM was scrutinized by the Company’s Hong Kong share registrar, Computershare Hong Kong Investor Services Limited.
