POSITIVE PROFIT ALERT

This announcement is made by Future World Financial Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) in accordance with Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) concerning disclosure of inside information and Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The Board of Directors (the “**Board**”) of the Company wishes to inform the shareholders and potential investors of the Company that based on the unaudited consolidated management accounts of the Group and the information currently available to the Company, the Group expects to record a net profit of approximately HK\$317 million (the “**Net Profit**”) for the six months ended 30 June 2017 as compared to a net loss recorded by the Group for the six months ended 30 June 2016.

The Net Profit is mainly attributable to increase in net profit from the segment of securities trading and investment which includes net unrealised gain of investments at fair value through profit or loss of approximately HK\$267 million.

The Company is still in the process of finalising the consolidated results of the Group for the six months ended 30 June 2017. This positive profit alert is only an assessment by the Board based on the information currently available, which has not been reviewed nor audited by the Company’s auditor. Shareholders and potential investors of the Company are advised to read carefully the announcement of the Company in relation to the results of the Group for the six months ended 30 June 2017, which is expected to be released in late August 2017.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
